These are services provided to South Gippsland Hospital clients by another entity, at an agreed price, with that entity being responsible for their own workforce and business costs. This includes but is not limited to some Allied Health services, small building works, aids and equipment, personal and respite care, domestic assistance, transport services and others as required. Costs for contracted services are charged according to each contractor's rates and/or fees.

SGH will establish a Service Agreement with preferred contractors who have been screened for suitability to deliver services to clients.

Clients may also nominate a provider to deliver their services, where suitable and in accordance with the Support at Home guidelines and legislation (subject to SGH approval).
